- "Sequential decision-making classroom events in which students fulfill assigned roles/tasks ... within an environment that models reality, according to guidelines provided by the instructor."

## Why Use Simulation?

- Real-world issues, but in safe learning environ
- Model reality, simplify complex realities
- Enhance student motivation
- Positive attitude toward learning
- Autonomy, responsibility, power to students
- Skills: collaborate, lead, decide, communicate
- "Gamification" of learning: fun, goals, rules
- Enact, apply, learn-by-doing, learn for purpose

## **Modeling Complex Realities**

- "Simulations have the power to recreate complex, dynamic political processes in the classroom; ...allows students to examine the motivations, behavioral constraints, resources and interactions among institutional actors."

#### G-20 Summit Simulation in HK

- What is the G-20?
- Transnational Coordination to Solve Big Global Problems in an Era of Rising Nationalisms
- Annual summits; "sherpas" meet prior for prep
- 20 country teams (or fewer to simplify)
- Min 4 Max 6 students per team
- Roles: HOS, Foreign, Finance, Environ Minsters
  - Health/welfare; education (at EdUHK); press

#### G 20 Heads of State

 Terrorism is unacceptable in all our nations. How can G- 20 states work together more closely to prevent the outbreak of terrorist incidents, and to prosecute the perpetrators, and their supporters, of acts of terror on innocent citizens? In particular, how can we prevent the uses of the Internet to promote terrorism, even while protecting the rights and freedoms, including privacy, of law-abiding citizens and commercial groups to use the Internet in the process?

# OTA: Negotiation Scenario (1)

#### 1. Tariffs

- The Trade Agreement will contain a chapter on tariffs. The
  objective is to eliminate virtually all tariffs between the
  participating countries. Only a very few products will be considered
  for an exemption.
- All tariffs will be eliminated according to one of the following schedules:
  - Immediate elimination upon entry into force of the agreement
  - Five year elimination period, 20% reduction per year
  - Ten year elimination, 10% reduction per year
  - Exempt from elimination
- Negotiate a tariff elimination schedule for two product categories:
  - Consumer electronics
  - Rice



## OTA Scenario (2)

#### **Digital Commerce**

- The Trade Agreement will contain a chapter on digital commerce. The objective will be to liberalize internet and electronic commerce to the maximum extent possible.
- For this opening round of negotiations, you will negotiate on the specific issue of local data storage requirements. You will need to address these points:
  - Shall any and all local data storage requirements be prohibited under the PTA?
  - If local data requirements are to be permitted under some circumstances, you must precisely define what those circumstances are.

#### Design the Sim Sequence

- How much time? What space can we use?

- Team formation and team building

#### Issues in Simulation Design

- Pressure to make a deal; constraints at home
- Use of online communication with F2F
- Journalists interview delegates; report; blog, etc
- Side-bar bi-lateral meetings on other issues
- Decorum and formal meeting rules
- Chairs of sessions; keep time; name tags; signage
- Intervening events, surprises, quick responses
- No-deal outcomes are also OK; reflection time
- Working group; sim committee; X-discipline
